重要備忘:就實任員工紀律問題研訊的政策指引及程序進行諮詢

各位同事:

- (一) 在聖誕及新年休課期間,人事部主任陳羅潔湘女士發出一份文件,題為「就實任員工紀律問題研訊的政策指引及程序進行諮詢」。
- (二)校方建議授與校長史無前例又不受限制的權力,好讓其行使由他「獨享而絕對的酌情權」,以決定是否可以直接成立解僱委員會,從而啟動開除實任員工的機制,再無須先經過非正式程序或內部研訊。同時,校長亦有權在解僱研訊未完成之前,暫停受研訊僱員的職務,並可在他認為有「急切需要」時,採取他認為必須的行動。
- (三) 對於這一些影響深遠的變化,究竟是否只求大大增加行政方便而犧牲程序公義,我們不得不深表關注。再者,任何挑戰學術自由的措施,必須經過學術 群體的深思熟慮、反覆研究。
- (四) 該份十九頁的諮詢文件,已發給各院長及系主任,他們被請求協助諮詢實任的同事,並於2009年1月22日前向陳太提交意見。
- (五) 不過,由於不為人知的原因,某些院長及系主任並沒有按人事部的請求,向 員工諮詢意見,剥奪了他們知悉該項重要的政策提議的權利。
- (六) 仍未取得實任的同事,同樣深表關注,因為今次諮詢只限實任同事,非實任同事均被摒諸門外。
- (七) 基於有關建議影響深遠,加上所謂諮詢實強差人意,浸大教職員工會理事會 現要求延長有關諮詢期四個月。
- (八) 與此同時,我們呼籲各位校董會及諮議會民選代表,盡力反映校內各種不同意見及關注。
